FIRE:

Chief turned in an invoice for \$166.52 which was approved by the Commissioners.

Chief presented a Proof of the Smokey and Fire Danger Sign that has been ordered for the front of the Fire Station. Total Cost \$ 997.37.

Chief discussed repositioning of the Flags on the front of the building to a full upright position attached to the back of the false front.

Chief noted that he will be attending a Fire Training session in VT on August 14.

WATER:Reviewed and answered e mails from DES regarding well site ID 508.
Noted that recent test sample results were all negative.**MISC:**

Com O'Brien contacted Mr. Rau regarding storm drains on Main and Pine Streets. Mr. Rau advised that they would be repaired in a couple of weeks.

Chief Paquette requested that Commissioners delay sending Scholarship check for Madison, as she might be changing her choice of Schools.

Chief Paquette also noted that tenants at 5 East Street have noticed an influx of rats in the area, due to the unsanitary condition of the burned out building


across the street. Com O'Brien requested more information including whereabouts of the property owners in order to proceed.

A business owner within the Village has complained about having to purchase a permit for building addition and building of a fence and has refused to do so. He was notified that he is currently being assessed \$100 per day that he is in violation. Assessment began on July 13, 2018.

An out of town property owner is selling property within the Village and wants a refund on their water bill. Com O'Brien will fax a copy of the paid invoice to their attorney and they can rectify the invoice with the new owner that way.
