## FIRE:

Chief presented invoices totaling \$ 1,965.80, plus November payroll of \$ 2,376.41, all approved by motion from Com Colburn, Seconded by Com Aumand. Two in favor.

Chief noted that this was the end of his fourth year as Chief of the North Walpole Fire Department. Commissioners thanked him for his service. Com Aumand made a motion to appoint William Crawford, as North Walpole Fire Chief for the ensuing year, Seconded by Com Colburn. Two in favor. (Note Com Kiniry voiced his approval by telephone).

Chief Crawford has completed his investigation regarding some questions concerning the completion of requirements at the Gay property on Len-Tex Lane. In checking the regulations and discussing with the State Fire Marshall, Chief found that Mr. Gay is not required to Sprinkler the property based on the materials stored there; he is also not required to have an alarm system installed as long as he has fewer than 15 employees. Chief Crawford will is scheduled to meet with Mr. Gay at 7:00 pm on Friday, to have this discussion.

11 Merchant Street: Chief Crawford has received written permission from the owners to do a health inspection of the property, which he did in conjunction with the Walpole Police Department. The PD is currently assisting the current inhabitants to find other lodging. Chief noted that the interior and exterior of the building is destroyed and he encourages the owners to board up and secure the building as soon as the current inhabitants have relocated..

Chief noted that the North Walpole Firefighters Association received a donation from the Bellows Falls (VT) Elks of \$400.
