Hooper Scholarship Committee- Kim Lewis

Reviews the process for the scholarship application and committee work. Meet in Early June to review new applications and reports submitted by existing scholarship recipients. Generally first year applicants get a smaller amount until they have proved themselves. Amazing pool of students. Also open to adults. As long as the learning is aligned with the mission. Students who leave the public school system are not as easily accessed and might not be tapping in to the funds. Would like to improve reaching that population.

Discussion about a Hooper Institute annual report that tells stories of the work in the K-12 program and the scholarship program. Additional tool for getting the word out.

Applicant pool- 2-6 per year.

Budget review- Current obligation is about \$32,000 per year. Spending down accrued interest. Current balance is around around 66,000. At current rate of spending, the accrued interest will be gone in two years and since the Trusts are co-mingled, which was mandated by the Office of Charitable Trusts. Trustees of the Trust Funds chose to add a .5 FTE to support a growing Hooper Institute. Need to focus on generating revenues to maintain sustainability. Two years to work on solutions. General brainstorm on possible solutions. Friends Of Hooper can

include scholarship fundraising in it's focus. Moving ahead, the Scholarship committee will be a subset of the Hooper Committee.

Capital Reserve Financial- In order to move the money out of the capital reserve fund (which is of unclear origin) at Cambridge Trust. Karen needs a letter from the Trustees of the Trust granting permission to transfer that money out of that account into the new Hooper checking account. Cheryl will follow up on that. Karen Galloway can help clarify what the money is and where it came from. Discussion about putting some of that in PDIP because it gets a higher interest than a traditional CD. Using the town's VIN to start a bank account facilitated that process.

New Members:

Liz Collinsworth, Jon Meadows. Holly reviews the process for becoming a member of the Board. Elaine Heleen is cycling off the Board, she was the liaison to the Conservation Commission.Cheryl is the Selectboard liaison to the CC also. Heather Brady is a question. May be retain her as FoHI as the Institute meeting times are not lining up with her schedule.

FOHI fundraiser- Trail run is scheduled for May 16th. Commitment secured from 4H to help run the event.

Summer Work Program

General discussion about the process and status of Helen's plans. Suggest that Andrea Sawyer get in touch with Helen to discuss improving the hiring process. In the past the deadline for submitting an application has been firm, which is positive.

Summer Camp- Helen is considering charging for summer camp. \$50 per week. Two sessions. On the sign up, include a line for sponsor another camper. Will we lose kids by charging? No one will be turned away. There will always be "scholarships" Cheryl suggests a conversation with Justin Cassarino about how he addresses funding kids. Research liability issues that may arise from charging. Also if we open ourselves to being subject to day camp regulation.

Additional Business: Logo Review and Discussion. Helen shares a piece from a graphic artist she has contacted. His rate would be \$200. Purpose of a logo is to identify an organization. Sources of advice in the community: Jan Kobeski, Karen Andrus, Liz Collinsworth's daughter, Rebecca. Board directs Helen to continue with her current path. Hoping to get a b/w version, maybe a color version. Style guide.

Helen is attending a meeting of various education organizations at Orchard Hill.
