There was a motion to approve the Treasurer's Report as written by Cmr. Vose, seconded by Cmr. Adams. Motion passed unanimously.

**Report of the Chief:** (1)Chief reports has met with Jason from Pierce and finalized plan for pumper truck, few changes in plan design, plan available for any interested. 2) Chief reports we are in process of submitting for active shooter grant, approved for \$6,000 3) Chief reports we are intending on purchasing a new base station radio, applying for gofer funds to cover cost. 4) Chief reports he has attempted to reach out to prior architect, not successful in connecting yet. 5) Chief reports that we are thinking about doing a drive by pickup for annual lobster and clam appreciation day. 6) Chief reports we are ready to advertise old ladder truck. Cmr Vose made motion to accept report of chief, Cmr.Adams seconded. Motion passed unanimously.

**Old Business:** 1) Current ladder truck is out of service, can advertise for sale, Cmr. Sawyer to coordinate with Jesse Moore regarding outside interests in classic fire equipment as well as inquire as to fees for advertising on auction sites, minimum bid/reserves, etc.

**New Business:** Treasurer Meister reports that we are submitting payroll documents for a workers comp self audit, due July 27.
