Chief noted that they were planning a Joint Training session on Fall Mountain/Mt. Kilburn with the Walpole Fire Department on October 29, 2020.

Chief and Commissioners continued discussion on the Departments and the Villages problems with the internet service. Com Kiniry has talked with Denis Marcom, who is on the Broadband Committee for the Town. Mr. Marcom will be in contact with Consolidated and will try and get the North Walpole offices on the list of the first upgrading, which they hope to do by early December, 2020.

### WATER:

Bob has discussed replacing the Hydrant on Cray Road with Eric of E E Houghton and will ask for an estimate to install a hydrant at the end of Willow Street.

Bob and Patrick will begin taking water samples to send to Trojan in Canada as part of the requirements of the Engineers.

### **HYDRANT FLUSHING:**

Hydrant Flushing will take place on Saturday, October 17, 2020 starting around 9:00 am.

#### MISC:

Some residents from the upper level of the Village have contacted Com Aumand about the lighting at the basketball courts near the North Walpole School. They need to be fixed/changed as the lighting is nil and people are unable to play basketball in the evening.
