Village received an Email from DES regarding testing for PFAS. According to the requirements the Village must complete four quarters of testing, before applying for a waiver.

It was noted that the Village Water Department needs to do Chemical Monitoring and the PFAS tests this quarter. Com Kiniry with check with EAI about the bottles and pick them up in Swanzey.

Bob will meet with Eric, of E E Houghton and get estimates for repairing/replacing the fire hydrant on Cray Road and installing a hydrant at the end of Willow Street.
