Commissioner's Meeting called to order at 7:04 pm, January 05, 2021.

Minutes of Dec. 29, 2020 approved by Motion from Com Kiniry, seconded by Com. Colburn. Three in favor.

FIRE:

Chief had one invoice for \$25, which approved by motion from Com Colburn, seconded by Com Aumand, with all three in favor.

Chief noted that they received an electrostatic sprayer for sanitizing the EMS equipment due to cov-id money.

Chief noted that most of the Department's members are scheduled to receive the co-vid vaccine.

Chief advised that a belt on the ATV was up for recall and that Jason would take care of it.

The 2021 SOG's and Procedures have been finalized and the Chief presented the Commissioners with a copy.

Chief presented his tentative 2021 Fire Budget for review and comment. He noted that 2020 the budget was \$100,620 and his tentative 2021 budget is \$102,000.

WATER:

4th quarter DBP and Water Use reports are complete and will be sent to DES on Wednesday.

Bob has made some adjustments with the WTB filtration system which should reduce the complaints about water staining household plumbing.

Water samples will be taken Wednesday and Patrick will deliver to Swanzey.

1,4-dioxane violation notices will be hand delivered to the lower level residents on Sunday, January 10, beginning around 9:00 am.

A Zoom meeting is scheduled with W&S on Tuesday, January 12, 2021 at 7:30 pm to discuss the Concept of Design for the WTB. It will be a question and answer session.

MISC:

Due to recent burglaries within the Village, a group has been formed and requested permission to post signs offering rewards for information leading to apprehension of the perpetrators. They would like to post a sign on the Green Backboard in the upper level of the Village. Motion by Com Kiniry, Seconded by Com Colburn to approve the posting of the sign at the place requested and voted in favor by all three Commissioners.

A tentative date of Tuesday, March 30, 2021 has been set for the Village Meeting. A formal announcement will be made at a later date.
