**Melissa Colburn was not in attendance.**

**FIRE:**

**Chief arrived after a medical rescues call. No invoices this week.**

**This Saturday, Chief and two members will go to NY State for final inspection of the New Fire truck. If all goes well, it should be in North Walpole within the next couple of weeks.**

**Chief has ordered three new gas sniffers(Meters) at \$600 each.**

**Last week Rescue responded to a medical emergency on Center Street. Neither Fire nor Police could gain access to the house, so Chief had to break in the door. Afterward Chief purchased and replaced the resident's door.**

**Department needs to replace Air Paks. Due to the cost, Chief is trying to obtain grants.**

**Chief advised that as soon as paperwork completed he will present a new member to the Department.**

**WATER:**

**Due to pending sale, Title Company has requested a final reading of water usage at 30 Center Street.**

**Com Kiniry received call from Sam Kenny of W&S with OMN per year costs. Increase per year costs about \$5,000; UV bulbs \$2,400; Chemicals \$3,000 and GAC replacement \$1,000. Media change every five years. Total Cost of OMN approximately \$11,000**

**MISC:**

**Village Book proofs have been approved. Books should be ready around March 23, 2021. Meeting is Tuesday, March 30, 2021.**

**Consolidated will connect Broadband to Office and Water on March 24, 2021.**

**Chief Crawford noted that they would do Fire Department on Friday,**

**7:40 Resident Alice Maurer of Center Street joined the meeting. She is interested in learning more about the Village. The Commissioners and Chief gave her a brief outline of the Village and activities.**

**On March 11, NH DOT held a Zoom meeting on the upcoming repairs to the "Church Street Bridge". They expect to start on April 5, 2021 and be completed by October 29, 2021. There will be restricted access and large trucks will be detoured. Total cost is \$1.7 Million Dollars.**

**During the discussion, the NW Commissioners asked about upgrading the Signage at the New Hampshire end of the bridge. A better, larger YIELD SIGN and a sign to use directional signals need to be installed.**

**New LED lights will be installed by Liberty Utilities and Town of Walpole will pay the electric bill.**
