**As requested, Bob checked the water meter at 11 West Street and found no problem with the meter. Apparently the last two sewer invoices have been higher than in the past.**

**Bob will take water samples for Bacteria and 1,4-dioxane on Wednesday and deliver to Swanzey for testing.**

**Bob was contacted by Todd at Dunning and asked about the need for a back flow on a new sprinkler system they were having installed. The Village does not have a requirement of replacement of older systems but there are regulations for new buildings, depending on the size of the building.**

**Ms. Maurer, also, was wondering when the North Walpole Branch of the Library would be open for use by residents.**
