**FIRE**

**Chief had one invoice for \$2,100 for two members to attend EMT classes in Goshen. Commissioners congratulated Chief and Department Members for Job Well Done in attending the 911 Walk in Bellows Falls . A young member of the Department, Jason Colburn, Jr. was featured in the Brattleboro Reformer and in USA today.**

**WATER:**

**Eric Smith of EE Houghton is checking the “dig safe” are on Hillcrest in preparation for installing a Fire Hydrant. This needs to be done prior to the paving of Hillcrest.**

**Patrick and Bob met with James Burns of 11 Willow Street and discussed tapping into the 2” plastic line running down Mountain View. Need to discuss with Eric Smith as to when they can do this work.**

**Bob talked to NHDES about using copper sulfates to reduce the vegetation growth around the reservoirs. NHDES discourages the use of this product near water sources.**

**Clearing the vegetation in and around the reservoirs and wells needs to be done soon. Patrick and Bob will try cutting this back. It was mentioned by Cheryl Mayberry that perhaps the Town could brush hog the area.**

**Bacteria water samples were delivered to EAI and results came back negative.**

**It now appears that NE Earth will commence work on the WTB on Sept. 19.**

**Unpaid water invoice residents will be receiving a visit from Patrick and Bob on Sunday, Sept 25.**

**Zoning ordinance committee: Next meeting is scheduled for Sept. 22, 2022**

**Celeste Aumand has been checking throughout the Village and noticed that many of the signs have gone missing. Town needs to add signage throughout the Village.**

**Wrong way traffic on Center and Vine is getting worse, as is the speeding. Patrick will once again check with the Police department about what can be done about this problem.**

**Billy Aumnd, 23 Church Street is planning a HUGE yard sale. Commissioners are concerned about traffic control during the sale.**
