**Hooper Forest Timber Harvest Prospectus:** Ms. Mayberry said at the harvest proposal by Alex Barrett was reviewed at the September Conservation Commission Meeting. The cutting detail and the treatment of invasive species were discussed at that meeting. Mr. Barrett will attend the October Conservation Commission Committee Meeting with a cost proposal.
