Mr. Foster advised that he had responded through e-mail stating that when the Courts issued a cease and desist order to Mr. Gay, the ZAO (Mr. Foster) advised that the length of the permit was delayed until such time as the court case was settled. As soon as the Court case was settled, the building permit was activated again, which gave Mr. Gay six months in which to start his project. Mr. Gay as put an excavator on his property and started work on March 6, 2018, well within the six month period.

Vachon (Auditors) will be at North Walpole on Monday, March 12 to Audit the Village's accounts.

Preston Young, from Governor Sununu's office forward information on the Silver Jacket organization regarding river erosion along the Connecticut River in response to a letter sent to the State by John Foster.

Com. Walker arrived at 7:45 pm from a meeting at the School.


ZONING:

Mr. Foster, ZAO, was seeking some guidance as he was concerned about noise and what problems the vibration might cause in the area.


Mr. Lake advised that the machine was actual a compacting machine for testing the soil in the area of construction. He advised that the noise would be minimal as would the vibration.

Motion by Com Walker and Seconded by Com Kiniry to adjourn the Meeting at 8:25 PM. All three in favor.


