Bob advised that both GPW's 507 and 508 were both tested and samples sent.

Bob noted that the areas around the River Wells needed mowing. He will take Mr. Colburn down and show him the areas involved.

**MISC:**

Invoice for water pipe replacements on Mountain View was received and reviewed from E E Houghton & Co for \$19,000. Motion from Com Kiniry, seconded by Com Colburn to accept and request money from Water Capital Reserve Fund as per Article 13 as voted at the Village Meeting of April 2019. All three in favor. Note request sent to Trustee of Trust Funds.

Commissioners authorized a certified letter be sent to James Cunningham immediately.

**GRANT MONEY:**

Com Kiniry met with a member of Rural Development on July 08, 2019 and signed documents for the Village to receive up to \$900,000. This is the ECWAG Grant Agreement.
