**WATER:**

Bob is expecting the DES to do their usual Sanitary Survey around the end of September, 2019.

Bob noted that the new State Requirement mandate that water supplies be tested for PFOA's starting in the fourth quarter this year.

**MISC:**

Cheryl Mayberry reviewed the Grant/Loan/SRF monies that the Village has applied for to upgrade the Treatment Building, specifically for the reduction/removal of 1,4-Dioxane.

The \$ 700,000 from the Trust Fund has been approved with a 20 year payback.

Com Kiniry received a letter from the USDA that the Grant of \$500,000 has also been approved.

Ms Mayberry mentioned a couple of items that were needed, one is an assessment management and the other is a design of the treatment building..
