Commissioner's Meeting called to order at 7:00 pm, January 27, 2020.

**FIRE:**

Chief noted that Department has been without Internet for two weeks. Looking into switching from Consolidated. Commissioners suggested contacting Consolidated and waiting switching over as Town is looking into upgrading area to Broadband.

Deputy Chief Aiken has obtained a cost to have fire extinguishers inspected.

Due to age and NFPA requirements the tires on all fire vehicles need to be replaced. This is required on all tires over seven years old for insurance coverage.

Chief noted that two firefighters have received Ice Rescue Certification.

Chief would like to take an Instructor course for Ice Rescue, in order to be able to run classes locally. Cost is \$2,200.

Motion by Com Kiniry for the Fire Chief to apply for the course and to appropriate the \$2,200 to cover the fee. Seconded by Com Aumand. All three in favor.

**WATER:**

Blue prints for the Water Treatment project is in a PDF file and needs to be transferred to a thumb drive.

During the project, the Water Department Computer needs to be upgraded.

Commissioners will meet with Project Engineers on Tuesday, February 11, 2020 at 4:00 pm to finalize plans.

**MISC:**

Need to check with Select Board concerning agreement that they would pay for a sign leaving the "Arch" bridge entering New Hampshire stating "Please use your directional signals". This was at a meeting in 2009.
