Commissioner's Meeting called to order at 7:04 pm, March 17, 2020.

Minutes of March 10, 2020, Motion by Com Colburn, Seconded by Com Kiniry to approve Minutes as written. Three in favor.

FIRE:

Chief noted that the Fire Station is closed to everyone except Firefighters, Emergency personnel and Mutual Aid personnel, in includes children as well as Adults.

Com Kiniry met with Mike Rau and Mark Pelow and discussed the Maple Street Project. Fuzzy Brothers will be tearing up the pavement and sidewalks and Mark Pelow Paving will do the street paving and replace one sidewalk and curbing.

Commissioners reviewed the bids received. Motion by Com Aumand to accept the bid of E.E. Houghton of \$ 34,200 to replace 300 feet of ductile water main, 7 new water services and a hydrant at the end of the street, Seconded by Com Colburn. Com, Kiniry, Colburn, Aumand all voted in favor.

Commissioners and the Town are planning on completing this project by Mid-June, 2020.

There are currently 24 unpaid water invoices.
