Com Kiniry called meeting to order at 7:09 pm.

Minutes of May 04, 2021 approved by Motion of Com Kiniry, seconded by Com Aumand with three in favor.

FIRE:

Chief presented following invoices totaling \$ 167.33. Approved by motion from Com Aumand, seconded by Com Kiniry with all three in favor.

Chief turned in \$50 from FF Pecor for repayment from uncompleted training course.

FF Pecor requested that the outstanding balance be reduced due to personal reasons.

Travis DeCamp of DeCamp trucking has been having discussions with Ben Hoy of Walpole Recycling about Village rubbish. Mr. DeCamp wishes to deliver the Village rubbish direct to Naughton & Sons Recycling in Bradford, saving time and man power. Mr. Hoy has advised Mr. DeCamp that he is in favor of this decision. Motion by Com Kiniry, seconded by Com Aumand for the Village to accept this change and to so notify Mr. DeCamp. All three in favor. Com Kiniry will call DeCamp on Wednesday, May 12, 2021 and confirm.

WTB, Zoom Meeting next week with W&S to discuss the 95% Final Design. Com Kiniry will set up meeting with Sam of W&S. Noted that Bob and Pat will co-share the Clerk of the Works position during the project.
