Meeting called to order at 7:03 by Com Kiniry

Minutes of August 31, 2021 approved by motion from Com Kiniry, seconded by Com Aumand, with three in favor.

FIRE:

Chief presented invoices \$744.98 which were approved by motion from Com Colburn, seconded by Com Aumand, with all three in favor.

Chief presented August payroll in amount of \$ 2,351.79, approved by motion from Com Aumand, Seconded by Comm Colburn, with three signing and in favor.

Chief turned in personnel payroll in the amount of \$ 240 which was signed and accepted by all three Commissioner.

Chief gave updated report on outside fire alarm. He contacted Mutual Aid and changed the hours of toning to between 7:00 am and 9:00 pm and only for fire calls. There should be no alarms sounded after 9:00 pm.

On Sept 11 there will be a Twin Towers Memorial Walk in Bellows Falls and some North Walpole members will attend. Walk will start at 8:00 am.

There is a plan to have Ice Rescue Classes around the end of December. They have begun inspecting the equipment.

In reply to the question of how many persons in the rescue boat, the Chief replied they limit it to 3 to 4 members, to allow sufficient room for who they are rescuing.

WATER:

Bob received notice for DBP 3rd quarter report. He does not believe NW needs to do it this year and he will call DES to be sure.

It has been noted that a huge crane is parked and blocking access to the Mountain View Pump House.

Patrick reported that Bids for the WTB were opened and Northeast Earth of Pittsfield, NH will be awarded the contract. Weston & Sampson is completing the details and work will start in the early Spring.

Water Department is looking at October 2 as the Collection/Shut off date for unpaid water bills.

Bob is looking to Flush Hydrant in Early October.

W&S is working with NHDES regarding the removal of water from the two GP wells prior to the Rehap work. Can the Village dump the water in the field or does it have to be moved off site?

MISC:

Celeste continues to be concerning about the School Bus picking up/discharging children at the foot of Mountain View Hill on Main Street. She is concerned with icy conditions in the winter. She will contact the SAU to try and get this changed.

Motion to adjourn the meeting by Com Aumand at 7:50 pm, seconded by Com Colburn, with all three in favor.
