FIRE:

Chief asked if they should do the pump test on the truck to enhance the sale.

Commissioners agreed that that should be done.

WATER:

Need to get bottles for Lead & Copper tests.

Bob will take samples for 4th quarter Chem Monitoring on Monday and Tuesday.

W&S and Commissioners, along with Northeast Earth, members from DES and USDA will have a pre-construction at the WTB on Tuesday, October 26, 2021 between 10:00am and 12:00 pm.

Water violation notices will be handed out either October 23 or 24, 2021.

Reviewed a letter from Barrett Electrical Instrumentation for Electric, regarding installing electric in WTB.

Bob will check the Library Toilet and fix.

According to Cynthia Holman, DSL service at the Fire Department has been removed and should lower their phone bill.

With the upcoming change in telephone dialing, switching to dialing 10 digit numbers, Mutual Aid suggested that the line system be upgraded in order to assure them of receiving all alarms. Chief will contact Amer Electric to do the upgrade.
