**Per Patrick's memo, noted that Old Engine 1 sale was still pending. He is still waiting to hear from a prospective buyer. He will call them later this week.**

**Looking to do Hydrant Flushing in May. Date to be determined.**

**Bob got an updated water meter reading at 3 Spruce for a pending sale. Checked out a complaint on Marshall Street and fixed the problem.**

**Celeste noted that she plans on painting the pump station posts on Mountain View red.**

**MISC:**

**WTB: Patrick's memo noted that NE Earth has prepped the rear parking lot and planned on paving it this week but had to delay due to the heavy rain.**

**Prior to starting the work, Patrick notified the Fire Chief and Police Sanctuary, via voice mail of the work being done.**

**Patrick spoke to Mike Rau about extending the paving in order to remove a crack in the seam on Russell Street. Mike gave him the go ahead to do that.**
