**LIBRARY LEASE:**

**The Library Lease was signed by all three Commissioners, recorded and mailed to Peggy Pschirrer, of the Walpole Selectboard.**

**The old riding lawn mower is for sale. Bob is interested and will give a bid. Patrick is also interested.**

Noted that all purchases from local businesses need to have a register receipt attached to invoices, per auditors.

Old Engine 1, is scheduled to go to Mason Fire department for \$40,000. Village waiting for final approval from Mason Selectboard and receipt of check. Broken mirror will be fixed prior to transfer.

There is a need for a Member to join the Walpole Power Committee to replace Patrick as his scheduled does not give him time to continue to be a member.

DeCamp will not be assessing NW a fuel surcharge and the residents must still use Walpole Trash bags as per agreement with Walpole recycling.

Members of the Zoning Ordinance review Committee consist of : John Foster, ZAO; Don Provencher, ZBA; Alice Maurer, ZBA; Celeste Aumand, Comm; Melissa Colburn, Com; Joe DiBernardo, Member at large.

New Owners of property on Willow Street, have been advised that because they are in a residential area they are not require to seek a site plan review by the Walpole Planning. All they need is a building permit from John Foster, ZAO of North Walpole. Based on this information, Mr. Foster has issued them two permits.

A lady who says her name is Janie Williams is apparently has an issued with the Walpole Police and was told by the Walpole Office to contact the North Walpole Commissioners. She did and Com Kiniry explained that the Commissioners had nothing to do with the Police department. She continues to call the NW office because she claims that when she calls the Town, either no one answers or they hang up on her and the same happens with the Police department. These are her allegations.
